1. Sanction of the competent authority is hereby accorded to the approval of the **balance amount of Rs. 4,50,000/- (Rupees Four Lakhs Fifty Thousand Only)**.
2. The above-mentioned amount may be appropriated across the original sanctioned debit heads such that the amount appropriated for a debit head (including expenditure and commitments so far, balance and new allocation) does not exceed the sanctioned amount for the debit head as per the original sanction order DST/NSM/R&D_HPC_Applications/2021/13 dated March 12, 2021.
3. The above-mentioned amount will be disbursed in installments at periodic intervals as reimbursements against the actual expenditure incurred in the previous period, by sending to the NSM office a statement of expenditure for the period that is signed by the PI and the financial unit of the PI’s Institution.
4. Supercomputing charges can be requested if the current balance in the PI’s project debit head is less than Rs. Two Lakhs. For such requests, only a maximum of 8% of the remaining in the sanctioned supercomputing charges, i.e., 8% of (total sanctioned supercomputing charges – total disbursed amount for supercomputing charges), at the time of this letter will be disbursed in an installment period.
5. In all cases, only the actual expenditure claimed till the project ending date will be considered for reimbursement.
6. All the terms contained in the original sanction order remain same.
7. The amount will be disbursed to **Registrar, Harish-Chandra Research Institute, Allahabad**.
