Sub: Reconstitution of Student Grievance Redressal Committee

In partial modification to Office Order No.27/2022, dt. 11th November, 2022, the Student Grievance Redressal Committee (SGRC) of HBNI is hereby reconstituted with immediate effect addressing the organizational changes in the HBNI administrative sections :-

1.	Prof. D. Dutta, Asso. Dean, HBNI	Chairpersor
2.	Prof. Naveen Kumar, Asso. Dean, HBNI	Member
3.	Prof. A.C. Bhasikuttan, OS, RPCD, BARC	Member

- 1. The SGRC will attend to grievances that are unresolved at the Cls/OCC level. This implies that all students shall first take up their grievance with the concerned authority in the CIs/OCC, and only if the grievance is not resolved satisfactorily at the Cls/OCC level, they should take up the grievance with SGRC of HBNL
- 2. The SGRC will co-opt Dean (Students Affairs) of two of the Cls/OCC, other than the institution to which the student, who has brought up the grievance belongs. The Chairman of SGRC can decide on the persons to be co-opted.
- 3. The SGRC may also invite a representative from among the students in the CIs/OCC as Special Invitee to participate in the deliberations in respect of the specific complaint.

Contd.....

- 4. The Committee shall have a term of two years or until further orders, whichever is earlier.
- 5. The quorum for the meeting, including the Chairperson, but excluding the invitee, shall be three.
- 6. In considering the grievances before it, the SGRC shall follow principles of natural justice. Accordingly, it will also seek inputs from the Dean (Students Affairs) of the concerned Cls/OCC and consider the same while taking a decision.
- 7. In the case of grievance from a female student, depending upon the nature of the grievance, the SGRC may decide to transfer the grievance to the Women's Cell.
- 8. The SGRC shall send its report and recommendations, if any, to the Director of the Cls/OCC concerned, with a copy thereof to the aggrieved student.
- 9. The SGRC may subsequently seek a report from the Dean (Students Affairs) of the concerned Cls/OCC about the action taken on the recommendation of the Committee.



- The Staff Grievance Officer (SGO) assisted by respective members is to deal with grievances of employees.
- SGO shall make herself freely available to hear the grievances personally, at least once in a week at fixed timings.
- Every grievance from the staff shall be registered and if a final decision is not possible within a fortnight, an acknowledgment shall be sent to the applicant along with an indication as to when he/she expect a final reply.
- SGO shall be specifically charged with the work of monitoring the grievances and ensuring that timely
 action is taken on the same. As a matter of general rule, no grievance shall be pending beyond the limit of
 the three months.
- As far as possible, a reasoned reply shall be given while replying to the grievance submitted by an employee.
- It should be the duty of every official to deal with the staff matters in a fair, impartial and speedy manner. Where Rules and Regulations have already been laid down by the Centre, the same should be applied uniformly, discretion, where permissible, should be used in a limited number of cases and in a manner which does not lead to dissatisfaction among other employees.
- In addition, the system shall also keep provisions for appeals by employees to the higher authority viz.
 Director, TMC / ACTREC with CAO, TMC and DIRECTOR, TMH as Apex Committee.
- The tenure of the aforesaid Committee shall be for a period of two years effective from 01.06.2024 or till further orders, whichever is earlier.



In partial modification to Office Order No.27/2022, dt. 11th November, 2022, the Student Grievance Redressal Committee (SGRC) of HBNI is hereby reconstituted with immediate effect addressing the organizational changes in the HBNI administrative sections :-

2.	Prof. Naveen Kumar, Asso. Dean, HBNI	Member

- 1. The SGRC will attend to grievances that are unresolved at the Cls/OCC level. This implies that all students shall first take up their grievance with the concerned authority in the CIs/OCC, and only if the grievance is not resolved satisfactorily at the Cls/OCC level, they should take up the grievance with SGRC of HBNL
- 2. The SGRC will co-opt Dean (Students Affairs) of two of the Cls/OCC, other than the institution to which the student, who has brought up the grievance belongs. The Chairman of SGRC can decide on the persons to be co-opted.
- 3. The SGRC may also invite a representative from among the students in the CIs/OCC as Special Invitee to participate in the deliberations in respect of the specific complaint.

Contd.....

- 4. The Committee shall have a term of two years or until further orders, whichever is earlier.
- 5. The quorum for the meeting, including the Chairperson, but excluding the invitee, shall be three.
- 6. In considering the grievances before it, the SGRC shall follow principles of natural justice. Accordingly, it will also seek inputs from the Dean (Students Affairs) of the concerned Cls/OCC and consider the same while taking a decision.
- 7. In the case of grievance from a female student, depending upon the nature of the grievance, the SGRC may decide to transfer the grievance to the Women's Cell.
- 8. The SGRC shall send its report and recommendations, if any, to the Director of the Cls/OCC concerned, with a copy thereof to the aggrieved student.
- 9. The SGRC may subsequently seek a report from the Dean (Students Affairs) of the concerned Cls/OCC about the action taken on the recommendation of the Committee.

- Every grievance from the staff shall be registered and if a final decision is not possible within a fortnight, an acknowledgment shall be sent to the applicant along with an indication as to when he/she expect a final reply.
- SGO shall be specifically charged with the work of monitoring the grievances and ensuring that timely
 action is taken on the same. As a matter of general rule, no grievance shall be pending beyond the limit of
 the three months.
- As far as possible, a reasoned reply shall be given while replying to the grievance submitted by an employee.
- It should be the duty of every official to deal with the staff matters in a fair, impartial and speedy manner. Where Rules and Regulations have already been laid down by the Centre, the same should be applied uniformly, discretion, where permissible, should be used in a limited number of cases and in a manner which does not lead to dissatisfaction among other employees.
- In addition, the system shall also keep provisions for appeals by employees to the higher authority viz.
 Director, TMC / ACTREC with CAO, TMC and DIRECTOR, TMH as Apex Committee.
- The tenure of the aforesaid Committee shall be for a period of two years effective from 01.06.2024 or till further orders, whichever is earlier.
