This Memorandum of Understanding (MoU) signed on the 27. No. ...day of ... July 2016.

### BETWEEN

Bhabha Atomic Research Centre (BARC), Trombay, Mumbai-400085, Department of Atomic Energy (DAE), Government of India, hereinafter referred to as BARC which expression shall include its successors-in-interest and assigns, of the one part

### AND

Indira Gandhi Krishi Vishwavidyalaya, Raipur-492 012 (Chhattisgarh), hereinafter referred to as IGKV which expression shall include its successors-in-interest and assigns, of the other part.

### PREAMBLE

WHEREAS BARC has a strong programme on crop improvement using nuclear techniques and has made substantial and significant contributions in terms of developing and popularizing new varieties of crops. BARC has strong expertise in the field of induced mutation breeding. BARC has developed 42 crop varieties in different crops for commercial cultivation. This crop improvement programme requires field testing of new mutants and selections in specific trials and an Agricultural University is an ideal place to conduct such trials.

unique land races have been collected from different parts and at Jagdalpur very rich biodiversity is present. In other vegetables viz. chillies, bottle gourd, brinjal, tomato, ivy gourd, ash gourd, bitter gourd, leafy vegetables seed, cucumber and pumpkin land races have been also collected.

Induced mutations by use of gamma rays can be used for improvement of these land races. One of the important advantages of induced mutation breeding is that it enables breeders to introduce specific improvements without affecting the existing good attributes/qualities of crop varieties. BARC has strong expertise in the field of induced mutation breeding. Therefore Induced mutagenesis with treatment of proper dose of radiation is one of the good options to improve these farmers' varieties/land races without losing its original quality. This breeding method help to reduce height and duration as well as some other drawbacks viz. grain shattering problem, long awns etc. The expected outcome will be: (i) development of high yielding varieties of cereals, pulses, oilseeds and vegetable crops (closely resembled to the farmers' varieties), (ii) development of cereals, pulses, oilseeds and vegetable crop varieties as per the need of farmers' (iii) development of variety with uniqueness or some special character viz red rice, medicinal rice, flaked rice making, low ODAP content in lathyrus, Omega -3 rich variety in linseed, good quality vegetables etc.

The application of nuclear techniques and research efforts are highly relevant in increasing productivity and production of the State. Bhabha Atomic Research Centre (BARC) has developed new techniques, materials and cultures which need large scale field experimentation. Active collaboration between BARC and IGKV will open new avenues for development in State agriculture as well as in the country.

# NOW, THEREFORE, IT IS HEREBY AGRREED TO BY AND BETWEEN BARC AND IGKV AS FOLLOWS:

 This MoU supersedes all previous discussion and correspondence on this subject matter.

### 2. SCOPE OF MoU:

This MoU aims at strengthening the linkages between Nuclear Agriculture and Biotechnology Division (NA&BTD), Food Technology Division (FTD) BARC and IGKV through a collaborative programme on

- 2.1 Breeding of new crop varieties, evaluation, release and notification.
  - 2.1.1 Testing and evaluation trials of newly developed mutants or selections (viz. rice, wheat, mustard, linseeds, soybean, mungbean, urdbean, groundnut, cowpea, pigeon pea etc.) developed by BARC or jointly developed by BARC and IGKV.

2.1.2 Providing field and laboratory facilities for growing and multiplication of hybridized segregating and irradiated population. Breeder seeds multiplication of Trombay varieties.

- c. The mutants/ selections advanced during the MoU period will also follow the same nomenclature system in the event of getting released after the period of MoU.
- d. Patents coming out of the MoU will be joint property of both the sides.
- e. Data produced under the MoU will be joint intellectual property of BARC and IGKV and the publication's authorship sequence will be as per their contribution.

### 6. Period of MoU

This MoU comes in effect from the date of its signing and will remain in force for a period of five years.

## 7. MoU implementation

Activities plan will be submitted by concerned scientists from both institutions. The plan for the season will be scrutinized by REAC of the university. Head, NA&BTD, and Head, FTD, BARC will be invitees for the meeting. The REAC along with Head NA&BTD, Head, FTD, BARC will carry out planning and review of MoU-activities.

## 8. WORK PLAN UNDER COLLABORATIVE RESEARCH: (Appendix-I)

## 9. ARBITRATION CLAUSE

Any dispute or difference arising between the parties shall be referred to the Director, BARC and Vice Chancellor, IGKV or any other person mutually acceptable to them. Their decision in the matter shall be final.

## 10. CONFIDENTIALITY CLAUSE

IGKV will not transfer any data obtained through this MoU to any other party in any manner whatsoever without prior written approval of BARC. Similarly, BARC will not transfer any data obtained through this MoU to any other party in any manner whatsoever without the prior written approval of IGKV. In case of replying to any possible RTI application regarding joint activities, it will be so done with mutual consultation.

### 11. NO LIABILITY CLAUSE

All activities will be carried out with due professional care. However, neither BARC nor IGKV shall claim from the other for any loss or damage whatsoever, resulting from implementation of any technology at the premises of the user(s).
